**Eligibility Criteria:**

1. The bidders should possess a minimum of three (3) years of experience in similar kind of work. The similarity & suitability of experience shall be assessed by Assam Cricket Association on the basis of documentary proof furnished for the purpose.
2. The bidders must not be blacklisted/suspended or have any service-related dispute with any Organization-Govt/Private/PSU's, etc.
3. The bidders must furnish copy of the PAN (Permanent Account Number) allotted by the Income Tax Department.

**Terms & Conditions:**

- i) The sale shall be on 'As is where is basis'.
- ii) The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rs. 50,000/- (fifty thousand only) by way of demand draft, which is refundable. The demand draft shall be drawn in favour of Assam Cricket Association payable at Guwahati. Bid (s) received without demand draft shall be liable for rejection.
- iii) All testimonials in support of the eligibility criterion including original instrument towards EMD and other documents in conformity with the requirements of the tender are to be included in a sealed envelope superscribing "Tender for disposal of scrap/ unserviceable items at ACA Stadium Campus, Barsapara, Guwahati" and shall be addressed to the Secretary, Assam Cricket Association, ACA Stadium, Barsapara, Guwahati-781018.
- iv) The sealed tenders should reach the Association latest by 10<sup>th</sup> April, 2024 by 03:00 PM and the bid will be opened on the same day at 04:00 PM in the Conference Hall of the ACA Office (1<sup>st</sup> floor) in the presence of the bidders (s) or their authorised representative (s).
- v) Bidders may inspect the scrap at the ACA Stadium Complex, Barsapara, Guwahati between 11:00 AM to 05:00 PM during working days before submitting their bids.





- vi) The successful bidder shall be required to deposit full amount within five (5) days of receiving letter of award/ Bid Acceptance letter and must lift the scrap material within ten (10) days of receiving letter of award/ Bid Acceptance letter
- vii) The bidder on receipt of letter of award/ Bid Acceptance letter, has to arrange for weighing the scrap items in presence of the representatives of Assam Cricket Association (ACA) at his/her own cost.
- viii) No enquiry of bidder shall be entertained once the material is lifted by them.
- ix) If there is any loss to the property of ACA while lifting the scrap, the bidder shall be solely responsible and has to compensate the loss
- x) All the scrap items have to be lifted in the presence and as per instructions of the authorised persons of ACA and on the basis of Gate Pass.
- xi) All labour, tools and equipment for loading the items from the site shall be at the cost of the buyer.
- xii) All applicable taxes & duties shall be extra which will be paid by the tenderer/bidder at the time of taking out the materials.
- xiii) The bid shall be submitted as per Annexure attached to this NIT.
- xiv) Assam Cricket Association reserves the right to accept in part or in full or reject any or more tender (s) without assigning any reasons thereof or cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected bidder or bidder (s).
- xv) Any kind of canvassing/seeking favour will lead to automatic rejection of the bid.
