## <u>Decision/Order of the Electoral Officer in respect of nominations of Representative etc.</u>

1. Perused letter no. (1) GU/ACA/2019/3387, GU/GUSB/resolution/2019/3386 dated 04.01.2019 and letter no. (2) GU/GUSB/ACA/2019/3388 dated 06.01.2019, of GU Sports Board. Vide Notification dated 4.01.2019, the Electoral Officer, Assam Cricket Association requested the GU Sports Board to re-submit names fulfilling the conditions laid down in the Memorandum of Association And Rules And Regulations of ACA. It is seen that the GU Sports Board has not submitted the proposal as per the following provision appearing at page 17 of the Memorandum of Associations And Rules & Regulations of ACA. The provision is quoted below:

"However, such representative shall be a former cricketer from the NF Railways, GUSB and DUSB, as the case may be and who is elected by an association of former players from the NFRSB, GUSB and DUSB, as the case may be, and not a person/s nominated by the Railway Sports Promotion Board/GUSB/DUSB."

Therefore it is regretted to say that the petition cannot be accepted and nomination of authorised representative to attend the General Meeting and the election to the Apex Council is rejected.

2. Perused letter no. DU/SB/ACA/2018-19/26/8046 dated 05.01.2019, of DU Sports Board. Vide Notification dated 4.01.2019, the Electoral Officer, Assam Cricket Association requested the DU Sports Board to re-submit names fulfilling the conditions laid down in the Memorandum of Association And Rules And Regulations of ACA. It is seen that the DU Sports Board has not submitted the proposal as per the following provision appearing at page 17 of the Memorandum of Associations And Rules & Regulations of ACA. The provision is quoted below:

"However, such representative shall be a former cricketer from the NF Railways, GUSB and DUSB, as the case may be and who is elected by an association of former players from the NFRSB, GUSB and DUSB, as the case may be, and not a person/s nominated by the Railway Sports Promotion Board/GUSB/DUSB."

Therefore it is regretted to say that the petition cannot be accepted and nomination of authorised representative to attend the General Meeting and the election to the Apex Council is rejected.
